

Amenia Town Basketball Information sheet, please take one

The Town of Amenia youth basketball program emphasizes Fun and Fundamentals. The athletes are divided into groups based on age and ability so as to provide the best experience possible.

The cost is set by the Town of Amenia, and covers officiating costs, jerseys for all players and miscellaneous expenses. The Town of Amenia will likely cover some of the expenses.

The program is overseen by Jon Zenz, AD WHS.

Coaches serve on a volunteer basis after being cleared by the Town.

Practices will be one night a week(most weeks) and on Saturday mornings(most Saturdays), end of November through February. Scheduling games is a difficult process, exact number of games is not determinable at this time.

Program groupings we are hoping to have;

- 1) **Instructional**, this is intended for first-timers, male and female. There will be 1 or 2 practices a week, with simulated "games" when appropriate
- 2) **Boys and Girls grades 3 and 4**, with some experience, within scheduling limits, they will play under more game-like conditions including a handful of games against outside programs, as well as in-house games.
- 3) **Boys grades 5-6**, this is intended for boys with some experience, games will typically be against outside teams as part of a league. Approximately half the games will be in Connecticut. There will be at least one practice a week in addition to game/practice on weekend.
- 4) **Girls grades 5-6**, this team will play most of its games against outside competition along with practicing at least once a week.

How many of these programs we run will depend on overall enrollment.
