

FEE SCHEDULE

Town Clerk Fees

Building Use:	\$50.00	effective 1/4/2018
Copies:	\$0.25	regular (8 1/2x 11) ea.
	\$0.35	large (8 1/2 x 14) ea.

Dog Licenses:

- Spayed or Neutered \$12.50 per year
- Unspayed/Unneutered \$20.50 per year
- Senior Discount is 10% (*applied to those over 60 years of age*)

Other Dog Fees: Impound Fees

1. Ten dollars (\$10.00) for the first impoundment of any dog owned by that person;
2. Twenty dollars (\$20.00) for the first twenty-four hours or part thereof and three dollars (\$3.00) for each additional twenty-four hours or part thereof for the second impoundment, within one year of the first impoundment, of any dog owned by that person; or
3. Thirty dollars (\$30.00) for the first twenty-four hours or part thereof and three dollars (\$3.00) for each additional twenty-four hours or part thereof for the third and subsequent impoundments, within one year of the first impoundment, of any dog owned by that person.
